Purpose & Explanation

This service entails the following tasks: Remote Terminal Unit / Intelligent Electronic Device (RTU / IED) programming, screen development, database development, field commissioning and startup and finalized documentation/ print generations. Proposals for the professional services were received from two firms qualified to perform this work. Advanced Control Systems submitted a quote of \$88,000 and The GPD Group submitted a quote of \$72,640. These services are budgeted in the 2018 HPP budget.

The City Administration is requesting City Council authorize the City Manager to award and enter into a contract with GPD Group, 520 South Main Street, Akron, Ohio for the required SCADA services for the
