

A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH DIAMOND WATERFRONTS TO PURCHASE AN ADA ACCESSIBLE KAYAK RAMP WITH INSTALLATION.

WHEREAS, the City of Hudson has been awarded a State Capital Budget Grant in the amount of \$62,700 to fully fund an ADA Accessible Kayak Ramp with no required match; and

WHEREAS, the City authorized the submission of a grant application on May 19, 2024, and authorized the City Manager to accept State Capital Grant Funding on June 17, 2025; and

WHEREAS, the installation of an ADA accessible boat/kayak launch dock at Hudson Springs Park, a popular destination within the Hudson Park System, will allow paddling activities to be enjoyed by individuals with disabilities, beginners, children, and seniors; and

WHEREAS, the project aligns with the current Park Master Plan and the Hudson Park Board's desire to focus on increased accessibility throughout the park system; and

WHEREAS, the state funding would be allocated for the purchase and installation of the ADA boat/kayak dock, asphalt paving for trail access, and one off-loading parking spot; and

WHEREAS, Diamond Waterfronts has presented a contract for the ramp and its installation, and the ramp can be acquired using cooperative purchasing pricing; and

WHEREAS, this project is in the best interest of the City and its residents.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, that:

Section 1. The City Manager is authorized to enter a contract with Diamond Waterfronts to purchase an ADA kayak ramp with installation at a total cost of \$62,700, utilizing Sourcewell Contract # 010521-LTS-2. The City Manager, the City Solicitor, and other appropriate officials are hereby authorized and directed to take all necessary and proper actions to implement the terms of said contracts and/or agreements.

Section 2. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
