A RESOLUTION AUTHORIZING THE CITY MANAGER TO ADVERTISE FOR COMPETITIVE BIDS AND TO ENTER INTO A CONTRACT FOR HEINEN'S PARKING LOT EXIT RELOCATION.

WHEREAS, the City of Hudson owns and maintains a parking lot adjacent to the Heinen's grocery store located on Clinton Street; and

WHEREAS, the current alignment of the driveway exit from the City parking lot poses access and safety concerns due to its proximity to the entrance of the Heinen's Grocery Store; and

WHEREAS, relocation and configuration of the parking lot exit is necessary to improve traffic flow and both pedestrian and automobile safety in the vicinity of the Heinen's grocery store; and

WHEREAS, the City desires to proceed with the project and must advertise for bids in accordance with applicable laws and enter into a contract with the lowest and best bidder for the completion of said project.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, that:

Section 1. The City Manager is authorized to advertise for a period of at least two consecutive weeks in a newspaper of general circulation within the municipality and for at least three consecutive weeks on the City's website, requesting the submission of bids for the aforesaid Heinen's Parking Lot Exit Relocation Project, all in accordance with the specifications as supplied by and on file with the City Engineer's Office.

Section 2. The City Manager is authorized to do all things necessary enter into and implement a contract for the Heinen's Parking Lot Exit Relocation Project subject to the approval of the City Solicitor and the affixing to the contract by the Finance Director of a certificate of availability of funds therefore, with the lowest and best bidder after receipt of such bids to the extent that such bid shall not exceed \$300,000, the amount budgeted for this project.

Section 3. The City Manager is further authorized to return all certified checks and bid bonds submitted by the unsuccessful bidders and to reject all bids for said contract if deemed necessary to do so.

<u>Section 4</u>. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

<u>Section 5</u>. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall be in full force and effect from and after the earliest period allowed by law.
