1. Call to Order

Mayor Anzevino called to order the meeting of Hudson City Council at 7:30 p.m., in accordance with the Sunshine Laws of the State of Ohio, O.R.C. Section 121.22.

Ms. Laura Erwin accepted the Proclamation on behalf of the local chapter of the National Society Colonial Dames XVII Century, and expressed appreciation for the recognition.

Mayor Anzevino read the Proclamation in its entirety, recognizing National Colonial Heritage Month.

6. Public Comments

Mr. David Firestein, 405 Rothrock Road, Akron, spoke on behalf of AJ Allison Enterprises, LLC, in favor of Council adopting Res. No. 23-111 to extend water to 6231 Chittenden Rd. He referenced passage of the following: Res. No. 23-75, revising water rates for service outside City limits; Res. No. 08-147, authorizing a Memorandum of Understanding between Hudson and Boston Heights for joint planning and economic development purposes along the Chittenden Rd. corridor; and Res. No. 14-21, extending water to 6217 Chittenden Rd. He noted that water line installation costs would be bourn by the developer, and the City would receive the tap-in fee and water revenues. He encouraged passage of Res. No. 23-111 for safety purposes on a "content neutral" basis.

Ms. Lisa Kamlowksy, Executive Director for Summit Developmental Disabilities Board, spoke as a volunteer for the Citizens' Levy Committee in support of Issue 17 on the November 7 Election Ballot, replacement of SummitDD's current operating levy. She said that the funds will maintain continuity of services currently provided, including residential, day, and employment supports; transportation and early intervention services; health and safety investigations; technical support; and oversight services. She thanked Hudson for its past support of SummitDD and encouraged support of Issue 17.

Mr. Steven Snyder, 7216 Hayward Road, spoke regarding the application for the Ohio Turnpike construction yard on Stow Road. He questioned Code authority of Section 1206.04 regarding the issuance of temporary use permits, currently approved administratively. He asked how the permit application satisfies this Code section in terms of site criteria, surrounding use, and not affecting public streets. He referenced correspondence to residents from the City Manager. He also noted a number of containers and trailers on the job site and questioned how the City is monitoring this, as well as the types of materials being stored on site. He said that construction activities have caused his home to shake and suggested the City monitor the site using a seismograph, as well as with noise equipment. He asked that the City revoke the permit and that Council fix the Code concerning permit authority.

7. Correspondence and Council Comments

Mr. Ruffer congratulated the Hudson High School Golf Team for winning sectionals and setting a school record. He announced that Mrs. Heater and he will conduct a meet & greet event at the Hudson Library on October 4th, and he encouraged those interested to attend.

Mr. Banweg thanked residents for feedback concerning water extensions and local policies concerning wells and City water.

Mr. Sutton provided an update on the Tree Commission, including: evaluation of the Moon Tree Program through NASA, update on storm clean-up, Scout Green maple tree replacement to be a hardier species, and the City Arborist now requiring a waiver for any structural evaluation on private property, due to liability issues.

Mayor Anzevino congratulated Economic Growth Board members on their new terms. He reported his activities, including EGB member swearing-in ceremony and speaking at Hudson Woman's Club meeting. He recognized Mental Illness Awareness Week and announced upcoming events: Candidate Round Table forum, voter registration deadline for the November Election, the last Hudson Farmers' Market of the season, annual Parade of Bands at Hudson High School, and a Safety Services Event at the Fire Station.

8. Report of Manager

Mr. Comeriato announced that a test of FEMA's warning system will occur at approximately 2:20 p.m. on October 4.

9. Appointments

Mr. Foster announced that there is an upcoming vacancy on the Planning Commission, and he encouraged interested residents to apply by the November 17 deadline.
