





First, and as a basic comment, district nine should be supported as a historic area, Darrowville. It feels sometimes like it's viewed as "lesser than" by the citizenry at large when it's the major southern entrance into our town. There are historic buildings down there repurposed for business, and I worry about their preservation. I don't live in District 9, but I think it is important as a gateway, so I don't like the thought what sounds like loosening zoning/broadening uses. Second, re: marijuana. A lot of dispensaries in other towns seem to look like cash-back store fronts or convenience stores, not shops. So I'd personally NOT like that sort of look for District 9. (I think the gas station on the corner of Norton is a mistake, for instance, but it's right on the border so we can sort of not claim it, almost.) If you must consider allowing a dispensary "shop," please tighten the requirements to match shops downtown. "Neighborhood scaled retail and service" is good, but it needs to look inviting. I do not believe dispensaries by tradition typically are. I'd also expect to see a 500 foot setback from St. Herman's, which isn't shown on your map. Besides being in a historic structure, it's a church. Kids use LifeCenter frequently and they have classes. Would a dispensary use be required to have a buffer from areas students congregate, like recreation areas, daycares, and dance schools? I'd hope to see those marked out, too, but I'm not sure of your definition of a "use of the same category." There are many other reasons I'd respond "no," but

those are a couple of concerns off the top of my head. Third: if "marijuana facilities" could also be used as a term for growth and production, please require a substantial buffer on the frontage, like you have on JoAnn's and the medical facilities. (Also, I'm not sure about how those sorts of places take care of air quality and such.) In summary, I'd vote to ban permanently because this district serves as an entry way. With that "Swiss Village" area now cleared out, and possibly LifeCenter going, now is the time to look at it as a prime spot...not a place for businesses that are less desirable. Long term, hopefully, we won't be in such need of building in our town.

Introducing marijuana dispensaries in District 9 could challenge the city's longstanding character and threaten the image that many of its residents value. Even if such businesses operate under strict regulations, the visibility of marijuana sales has the potential to shift public perception of the city. Longtime residents who cherish Hudson's traditional identity may view the introduction of dispensaries as undermining the values that have drawn families and businesses to the area for generations. Part of Hudson's appeal lies in the sense of safety and tranquility that locals and visitors alike find within its borders. The arrival of dispensaries could generate unforeseen pressures on law enforcement, including the need to address loitering, ensure safe transport of a cash-intensive product, and respond to incidents of theft. While a single dispensary might not overwhelm the police force, multiple establishments could gradually tax local resources, forcing the city to invest in heightened security and oversight. The added responsibility on law enforcement and emergency services potentially diverts attention from other community needs, thus affecting public safety across the board. Critics further worry about how visible marijuana sales can alter social norms, especially among young people. Despite strict age restrictions, a retail presence may inadvertently "normalize" marijuana use, encouraging underage curiosity. Schools, youth programs, and families that emphasize healthy, substance-free lifestyles could find themselves in conflict with a shifting cultural narrative. Consequently, educators and parents might face additional pressure to develop anti-substance campaigns or enforce new policies, all of which require significant energy and funding. This runs counter to the proactive efforts that currently uphold Hudson's reputation as a community invested in positive youth development.

Beyond social considerations, there are economic implications to weigh. Some property owners fear that the proximity of dispensaries could negatively affect real estate demand. Whether these concerns are warranted or not, the stigma surrounding marijuana shops may discourage certain buyers or tenants and complicate efforts to attract family-oriented businesses. Meanwhile, established restaurants, boutiques, and similar enterprises could see changes in clientele that they perceive as detrimental to their brand. Although some dispensaries operate as well-regulated, professional establishments, apprehension about loitering and public consumption remains a notable concern. Traffic and infrastructure also come into play. Businesses that draw a significant number of out-of-town customers can exacerbate congestion in neighborhoods that may not be equipped for higher traffic volume or heavier parking demands. Local leaders would need to dedicate additional time and resources to regulatory oversight—writing and enforcing ordinances specific to marijuana, developing buffer zones near schools, and instituting signage restrictions. These administrative burdens often require more staff and funding, which could strain city finances or shift municipal priorities away from other pressing projects. Community cohesion is another issue. The debate around dispensaries tends to be polarizing, potentially causing friction among residents who hold different positions. This discord can linger, creating an environment of tension that undermines Hudson’s tradition of collaboration and neighborly support. Furthermore, once marijuana dispensaries are permitted, it may become more difficult to limit additional cannabis-related businesses, such as lounges or production facilities. The shift toward a cannabis-friendly regulatory stance might complicate or disrupt long-term developmental plans, especially in areas previously envisioned as centers for entertainment, family activities, or community gatherings. In sum, many residents believe that the risks associated with allowing the marijuana moratorium to expire in District 9—whether related to community character, law enforcement, youth exposure, economic stability, or potential community divisiveness—outweigh any short-term gains in tax revenue or consumer choice. The character and reputation that Hudson has cultivated over the years could be jeopardized by the perception of a new, more permissive local atmosphere and the challenges that come with it. By preserving the moratorium or continuing to block marijuana dispensaries, the city can maintain its cherished community values, protect public safety, and ensure that the foundational qualities that have made Hudson thrive remain intact. I oppose the current proposed legislation because it allows these facilities in District 9, and only District 9 – the Southern Gateway to Hudson. There are several reasons for my opposition. First, the 2024 Comprehensive Plan specifically lists the Southern Route 91 corridor and the Historic Darrowville area as important goals of the Plan. The Plan spells out a commitment for needed improvements to the long-neglected Southern Gateway to Hudson. The new Comprehensive Plan states specifically the goal in section 1.3.3 – Darrowville Focus Area – Development and streetscape enhancements that work to create a unique gateway into the community AND RESPECTS THE HISTORY AND CULTURE OF THE AREA. Vape shops, Tattoo parlors and the like, as proposed in the 23-154 legislation DO NOT respect the history and culture of the area, they are contrary to the 2024 Comprehensive Plan, and should, therefore, not be allowed. Second, we have now learned that the City Solicitor has indicated that it WOULD BE allowable to ban these unsavory facilities in the entirety of Hudson, but yet Council continues to act as if that guidance never happened. Council ignored that legal advice, but only wants to “dump them” down in District 9. There are Hudson residents in and very close to District 9, just as there are residents in District 8 as you argued to protect in earlier Council discussions. We all want the best, most welcoming and safe environment in Hudson. Previously, I spoke at Council and indicated that if we needed to have one district to allow placing these facilities, I suggested that it be District 10. District 10,

located in the Northeast corner of the city, is the most remote, less traveled and very lightly populated area, that in my opinion, could be an alternative to the questionably designated District 9. In response to my suggestion, Council deemed District 10 was not acceptable “because of the limited existing commercial and the semi-rural nature of the area.” I think that Council missed the point. The point is that we WANT to make it as UNATTRACTIVE as possible for interests to establish these types of businesses in our town, and restricting their placement to a more rural area, with little established commercial development and minimal vehicle traffic makes it less likely they will come. Instead, Council wishes to “dump the garbage” in the Southern Gateway to Hudson, in the face of the Comp. Plan and virtually incentivizing the establishments of these businesses there. I have done some research into establishments in other towns surrounding us. I regularly drive through the intersection of North Portage Path and Merriman Rd, the Merriman Valley. I am disappointed to see that they have allowed THREE of these establishments to be located within about 100 yards of each other in that area! All of these type of establishments seem to have ugly, bright, flashing signs and blinding light from inside the store. I know that the response is going to be “that can’t happen in Hudson,” because of our signage code restrictions, but I have a story about the one business that probably inspired this current legislation, Puffy’s, who did sneak into the store front next to Chipotle at the corner of 303 & Atterbury. As soon as the store opened, they placed a brightly illuminated “Open” sign in the front window – in direct violation of Hudson’s sign code. I waited a month or so to see if it would be removed, but it never was. I then contacted the city’s Code Enforcement office, who had no idea that the sign violation had been put in place. Because of my intercession with Code Enforcement, the process to remove the sign began with a notification letter to Puffy’s. About a month later, they complied, but only by moving the illuminated “open” sign to the wall inside the building, taking it technically into code compliance, but still there. This is the type of businesses you are considering allowing to enter District 9 only, misfits and non-conformers that will stretch the rules to the limit and degrade the Southern Gateway to Hudson if they are allowed there. Also, there is no language in the currently proposed legislation to restrict the number of these establishments that can locate in this town, making it perfectly legal to have a situation like the multiple location condition that currently exists in the Merriman Valley, a sad and frightening prospect for the Southern Gateway of Hudson. A scary thought, indeed. Finally, there is a wonderful phrase above the front door to the U.S. Supreme Court building in Washington D.C. that states “Equal Protection Under Law.” It is the law of the land as spelled out in the 14th amendment of the U.S. Constitution. By proposing that 9 out of the 10 zoning districts of Hudson are protected from the establishment of these businesses, and the problems and blight that they will in all probability generate,

the legislation is not providing equal protection to those that live and work in and around District 9. I implore you to afford the Southern Gateway to Hudson the EQUAL PROTECTION that all other districts will have. DO NOT discriminate against the Southern gateway – PROTECT ALL OF HUDSON INSTEAD and a permanent ban on these types of establishments in Hudson. All of Hudson deserves equal protection and it is this Council's responsibility to see that equal protection applies to ALL AREAS of this fair city. Hudson is different for a reason. We do not allow front facing garages for a reason. We do not allow RV storage in driveways like adjoining communities seem to. That's because Hudson is different and expects better of the establishments in the community. Hudson is better than that and we at the South end of town also deserve better by not allowing these types of facilities in all parts of town. One major issue is the discrepancy in advertising restrictions—while alcohol and tobacco have strict limitations, marijuana businesses face far fewer restrictions, leading to increased exposure and normalization of drug use. 1. Impaired Brain Development The adolescent brain continues developing until around age 25, and marijuana use during this critical period can have long-term negative effects on memory, attention, and cognitive function (National Institute on Drug Abuse (NIDA)). Studies show that teen marijuana users have lower IQ scores later in life compared to non-users, even if they stop using (Proceedings of the National Academy of Sciences). 2. Increased Risk of Mental Health Issues Marijuana use has been linked to higher rates of anxiety, depression, and suicidal thoughts in teens (JAMA Psychiatry). Adolescents who use marijuana are at a

higher risk of developing schizophrenia and psychosis, especially if they have a genetic predisposition (The Lancet Psychiatry). 3. Lower Academic Achievement Teens who use marijuana regularly are more likely to struggle in school, have lower grades, and drop out (American Journal of Psychiatry). Heavy marijuana use can reduce motivation and impair problem-solving skills, leading to long-term educational setbacks. 4. Higher Risk of Addiction 1 in 6 teens who use marijuana will develop a cannabis use disorder, meaning they become dependent on the drug (NIDA). The risk of addiction is even higher for those who begin using at a younger age. 5. Increased Likelihood of Using Harder Drugs Studies show that marijuana can be a gateway drug, leading to increased risk of using opioids, cocaine, and other substances later in life (National Academy of Sciences). 6. Greater Risk of Car Accidents Teen marijuana users are more likely to drive under the influence, leading to higher rates of car accidents and fatalities (AAA Foundation for Traffic Safety). 7. Negative Effects on Social Development Teens who use marijuana regularly may struggle with relationships, social skills, and emotional regulation (NIDA). Note: Marijuana Advertising is Unregulated Compared to Alcohol and Tobacco Alcohol and tobacco advertising is heavily restricted to protect minors. For example, the Federal Alcohol Administration Act prohibits advertising that targets children, and the Master Settlement Agreement (MSA) placed strict limits on tobacco marketing. Hudson's values are built around family and safety so marijuana shops with flashy signage and promotional materials will normalize drug use among children and make it seem risk-free. More Dispensaries = More Youth Access to Marijuana Just like alcohol, when marijuana becomes more accessible, underage use increases. Data from Colorado (one of the first states to legalize marijuana) showed that teen marijuana use increased by 20% after legalization, with many teens obtaining marijuana from adults who purchased it legally (Rocky Mountain HIDTA Report). In Hudson, where law enforcement resources are limited, ensuring compliance with age restrictions will be even more difficult. Why make the police's job harder. They have important things to address. Increased Risk of Impaired Driving and Public Safety Issues A report from the AAA Foundation for Traffic Safety found that states with legal marijuana saw a significant increase in fatal crashes involving drivers who tested positive for THC. Unlike alcohol, where impairment levels can be measured through BAC (blood alcohol content), marijuana

impairment is harder to track, making enforcement more challenging for local police. Negative Economic Impact and Increased Crime Proponents argue that dispensaries bring in tax revenue, but studies show that the social costs of marijuana legalization often outweigh the financial benefits. A study from the Centennial Institute estimated that for every \$1 in marijuana tax revenue, the state of Colorado spent \$4.50 in health care, law enforcement, and social services costs. Legal marijuana businesses often attract criminal activity, including robberies and illicit drug trade, which will negatively impact Hudson. Is the extra money worth the cost of the reputation of the town? When property values decrease leading to lower taxes and money for schools? It's a downward spiral. The Stench This smell is not just a minor nuisance—it can significantly impact the quality of life, local businesses, and property values. Persistent marijuana odor has been linked to decreased property values. A study by the CATO Institute (2021) found that homes located near cannabis facilities suffered an average price decline of 8.4%, as buyers are deterred by the pervasive smell and its potential health effects. Local businesses—especially restaurants and retail stores—can also suffer as the unpleasant odor discourages foot traffic and deters customers from visiting nearby establishments. Despite claims that filtration systems and air scrubbers can mitigate the issue, many communities report ongoing odor problems even with such measures in place. The Colorado Department of Public Health and Environment has noted that no odor control technology has proven 100% effective in eliminating marijuana-related smells. The presence of a marijuana facility means an unavoidable, lingering smell that residents must deal with daily. This can be a major deterrent for residents and businesses Hudson striving for a clean and welcoming atmosphere. If you're trying to drive foot traffic, downtown marijuana facilities will not help. If you don't believe any of these facts, talk to the Akron Children's addiction specialists to hear what they see daily in our area-- not some "only on the West coast" problem but here in Summit County. Even if you argue that kids aren't allowed to legally use, don't be naive to think they won't try to get their hands on it (and succeed bc there will always be unscrupulous vendors willing to make money off our kids).
