

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ADVERTISE FOR BIDS AND TO ENTER INTO A CONTRACT FOR THE REPLACEMENT OF 48” STORM SEWER FROM THE NORTHSIDE OF STATE ROUTE 303 SOUTH TO AN EXISTING BOX CULVERT BESIDE ROSEWOOD GRILL; AND DECLARING AN EMERGENCY.**

WHEREAS, the City conducted a small stormwater study in late 2024, which identified a section of the City’s storm sewer under State Route 303 as a critical “choke point” contributing to upstream flooding; and

WHEREAS, the project involves upsizing the existing 48-inch storm sewer and box culvert to a new, higher-capacity box culvert, extending from the north side of East Streetsboro Street (State Route 303) south to the existing 4’x8’ box culvert east of Rosewood Grill; and

WHEREAS, construction is scheduled for the Summer of 2026 and is timed to coincide with Summit County’s State Route 303 Sanitary Sewer Replacement project, minimizing community impact; and

WHEREAS, the estimated construction cost is \$635,000, including contingency; and

WHEREAS, this project is in the best interest of the City and its residents.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, that:

Section 1. The City Manager is authorized to advertise for a period of three (3) weeks on the City of Hudson website requesting the submission of bids for the purpose of acquiring the lowest and best bidder for this project in accordance with the specifications as supplied by the City Manager’s office, including the replacement of a 48-inch storm sewer from State Route 303, south to an existing box culvert at Rosewood Grill.

Section 2. The City Manager is authorized to enter into contracts on behalf of the City with the lowest and best bidder on the subject project, so long as the contracts are in a form satisfactory to the City Solicitor and subject to the affixing to the contract by the Finance Director of a certificate of availability of funds therefor.

Section 3. The City Manager is further authorized to return all certified checks and bid bonds submitted by the unsuccessful bidders.

Section 4. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution is declared to be an emergency measure necessary for the immediate preservation of life, property, public health, safety, public peace, and the general welfare of the City, that the work will improve safety upon and around State Route 303, and for the further reason that it is immediately necessary to enter this agreement in a timely fashion to ensure that the repairs and improvements are made in good weather and improve safety as soon as possible; wherefore, this legislation shall take effect and be in force immediately upon its passage, provided it receives five (5) affirmative votes of members of Council, except that six (6) affirmative votes are required if all members are present; otherwise it shall be in full force and effect from and after the earliest period allowed by law.
