

**A RESOLUTION OF THE CITY OF HUDSON, OF OHIO, SUPPORTING  
THE OHIO COMMISSION FOR THE UNITED STATES  
SEMIQUINCENTENNIAL (AMERICA250-OH).**

WHEREAS, in 2026, the United States marks a historic milestone with the 250th anniversary of the nation's founding; and

WHEREAS, this semiquincentennial commemorates the signing of the Declaration of Independence in 1776 and invites all Americans to reflect on the country's history, ideals, challenges, and progress;

WHEREAS, the Ohio General Assembly and the Governor created AMERICA250-OH in 2021 to plan, encourage, develop and coordinate the commemoration of the 250th anniversary of the United States and Ohio's integral role in that event and the role of its people on the nation's past, present and future; and

WHEREAS, AMERICA250-OH hopes to engage all Ohioans and all of Ohio's 88 counties through their many signature and officially recognized programs, projects and events over the next several years by inspiring future leaders and celebrating all Ohioans contributions to the nation over the last 250 years; and

WHEREAS, America250 is both a celebration and a moment of civic reflection, honoring the past while inspiring dialogue and action toward a more inclusive and resilient future; and

WHEREAS, the City of Hudson desires to host and participate in the "America250" celebration.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, State of Ohio, that:

Section 1. The City of Hudson hereby endorses AMERICA250-OH and their mission to educate, preserve, innovate and celebrate EVERY Ohioan in EVERY county.

Section 2. That the Clerk of Council shall forward a copy of this Resolution to the AMERICA250-OH Commission and the proper municipal legislative delegation.

Section 3. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
