

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ADVERTISE FOR COMPETITIVE BIDS AND TO ENTER INTO A CONTRACT FOR THE INSTALLATION OF NEW CURB INLETS ON CLINTON STREET AT HEINEN'S REAR ENTRANCE.**

WHEREAS, in 2024, the loading dock area at Heinen's grocery store was temporarily flooded due to a nearby water main break; and

WHEREAS, after the water main break was repaired, City staff determined that installing a new City storm drain, or curb inlet, near the driveway to the loading dock area would help to alleviate the potential for future flooding in this area; and

WHEREAS, the new curb inlet installation (the "Project") will be coordinated along with the upcoming main parking lot entrance/exit reconstruction work at the City's parking lot in front of the grocery store, so cost savings can be realized; and

WHEREAS, upon completion of the entrance/exit relocation work and the County sanitary sewer project, the City's parking lot will be resurfaced; and

WHEREAS, a detailed design of the Project is being completed in-house by City staff; and

WHEREAS, the total cost of the Project, including a contingency, is not expected to exceed \$30,000.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, that:

Section 1. The City Manager is authorized to advertise for a period of at least three (3) weeks on the City of Hudson website requesting the submission of bids for the purpose of acquiring the lowest and best bidder in accordance with the specifications as supplied by the City Manager's office for the Project, i.e., the described Clinton Street Curb Inlet Installation.

Section 2. Upon receipt of bids for the Project, the City Manager is also authorized to enter one or more contracts on behalf of the City for the purposes outlined in Section 1 above in the amount appropriated by Council, subject to approval as to form by the City Solicitor and the affixing to the contract by the Finance Director of a certificate of availability of funds therefor.

Section 3. The City Manager is further authorized to return all certified checks and bid bonds submitted by the unsuccessful bidders.

Section 4. The aforesaid project is in the City and its residents' best interest.

Section 5. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 6. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 7. This Resolution shall be in full force and effect from and after the earliest period allowed by law.
