

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE HUDSON CITY SCHOOL DISTRICT FOR COOPERATION AND COST SHARING FOR THE FRANKLIN STREET SIDEWALK INSTALLATION.**

WHEREAS, in order to improve safety for students and pedestrians walking to and from the Hudson Middle School, a new 5-foot wide sidewalk is planned along the west side of Franklin Street between Aurora Street and the Middle School; and

WHEREAS, more specifically, this new sidewalk would provide a safer path for students going to and from the Middle School who walk to school, without having to cross the Franklin and Aurora Street intersection at school drop-off and pick-up times; and

WHEREAS, the sidewalk is currently scheduled for the summer of 2026 at a total cost of \$125,000; and

WHEREAS, the Hudson City School District has agreed to reimburse the City for the portion of sidewalk on its property in the amount of \$28,000.00; and

WHEREAS, with Council and the Hudson School Board's approval, the sidewalk installation is scheduled for the summer of 2026, in time for the 2026-2027 school year.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, that:

Section 1. The City Manager is hereby authorized to enter into a Cooperation and Cost Sharing Agreement between Hudson City Schools and the City of Hudson for the described Franklin Street Sidewalk Installation Project, subject to approval as to form by the City Solicitor and the affixing to the contract by the Finance Director of a certificate of availability of funds therefor.

Section 2. The agreement shall specify the scope of work, cost-sharing arrangements, responsibilities of each party, and any other provisions necessary to carry out the Project efficiently.

Section 3. The Finance Director is authorized to make the necessary payments as required under the agreement, subject to the availability of funds and in accordance with applicable laws and regulations.

Section 4. The aforesaid project is in the City and its residents' best interest.

Section 5. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 6. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 7. This Resolution shall be in full force and effect from and after the earliest period allowed by law.
