

A RESOLUTION AMENDING RESOLUTION NO. 25-38 TO INCREASE FUNDING FOR THE SNOW AND ICE CONTROL PROGRAM CONTRACT FOR PUBLIC PROPERTIES.

WHEREAS, the City Administration requested and, in Resolution No. 23-162, City Council approved the advertisement, bidding, and award of contracts for the 2024 Public Works Purchasing Program pursuant to the approved 2024 City budget; and

WHEREAS, included in the approved bids and awards was the City's Snow and Ice Control Program for Public Properties (the "Program Contract"); and

WHEREAS, the Program Contract was for services during the 2024/2025 and 2025/2026 winter seasons; and

WHEREAS, the winter of 2024/2025 experienced above-average precipitation and lower-than-normal temperatures for longer durations, resulting in elevated needs for services under the Program Contract, which, in turn, prompted the need for the increased funding authorized in Resolution No. 25-38; and

WHEREAS, during the winter of 2025/2026, the City again experienced elevated needs for services under the Program Contract due to harsher-than-normal winter weather and an increase in the number of areas serviced; and

WHEREAS, the City administration seeks an increase in funding for the Program Contract; and

WHEREAS, the requested increase is in the best interest of the City and its residents.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, as follows:

Section 1. The funding allocation for the Snow and Ice Control Program contract for public properties, as initially authorized under Resolution No. 23-162 and listed in its Exhibit "A," and as amended under Resolution No. 25-38, is hereby changed to \$376,000, an increase of \$26,000 from the authorization in Resolution No. 25-38.

Section 2. The City Manager and his designees are authorized to do all things necessary in order to proceed with contract modifications, expenditures, or additional procurements, as necessary, to accommodate the increased funding and costs.

Section 3. All other provisions of Resolution No. 25-38 shall remain in full force and effect except as amended by this Resolution.

Section 4. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
