

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ADVERTISE FOR BIDS AND ENTER INTO CONTRACTS FOR THE 2025 CAPITAL MAINTENANCE PROGRAMS OF THE CITY OF HUDSON.**

WHEREAS, The City Administration is requesting City Council approval to advertise, bid and award contracts for the 2025 Capital Maintenance Programs of the City of Hudson; and,

WHEREAS, the City's 2025 programs will include:

1. Line Striping
2. Crack Sealing
3. Concrete Replacement, which includes sidewalk replacement/repair and catch basin repair; and
4. Asphalt Resurfacing and Patching Program.; and,

WHEREAS, it is in the best interests of the City of Hudson and its residents that this programs be completed.

NOW, THEREFORE, BE IT RESOLVED by the Council of Hudson, Summit County, Ohio, that:

Section 1. The City Manager is authorized to advertise both for a period of at least once a week for two (2) consecutive weeks in a newspaper of general circulation within the municipality and for a period of three (3) consecutive weeks on the Municipal website, requesting the submission of bids for the award and enter into a contract for the aforesaid 2025 Capital Maintenance Programs of the City of Hudson.

Section 2. The City Manager is authorized to do all things necessary to award, enter, and then implement contracts for the 2025 Capital Maintenance Programs of the City of Hudson, subject to the affixing to the contract by the Finance Director of a certificate of availability of funds therefore, with the lowest and best bidder after receipt of such bids, and the approval as to form and correctness by the City Solicitor.

Section 3. The City Manager is further authorized to return all certified checks and bid bonds submitted by the unsuccessful bidders and to reject all bids for said contract if deemed necessary to do so.

Section 4. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
