

AN ORDINANCE AMENDING SECTION 410.11, SCHEDULE XI OF THE TRAFFIC CODE TO AMEND THE LIST OF STREETS DESIGNATED AS PARKING TIME LIMITED IN DESIGNATED PLACES AND SECTION 410.10 SCHEDULE X OF THE TRAFFIC CODE TO AMEND THE LIST OF STREETS DESIGNATED AS PARKING PROHIBITED AT ALL TIMES IN DESIGNATED PLACES; AND DECLARING AN EMERGENCY.

WHEREAS, Section 406.07 reserves to the Council the right to adopt various rules, regulations and proceedings in connection with traffic control; and

WHEREAS, based on resident request for No Parking designation during events at Barlow Farm Park, it has been determined that on-street parking along E. Barlow Road between Ogilby Drive and Terex Road decreases site lines and increases the chance of accidents; and

WHEREAS, based on a traffic safety study by TMS Engineers completed in October 2022 recommendations to improve both vehicle and pedestrian safety along N. Hayden Parkway between Hudson Aurora Street and E. Streetsboro Street, it was recommended that the city install NO PARKING signs at the school entrances, on the west side of N Hayden to ensure that adequate site distances are maintained during school hours when traffic is most congested; and

WHEREAS, Staff sent letters requesting input to those residents directly impacted by the installation of NO PARKING signs at each location and those residents responding were in favor of the sign installation.

NOW, THEREFORE, BE IT ORDAINED by the Council of Hudson, Summit County, State of Ohio, that:

Section 1: Section 410.11, Schedule XI of the Traffic Code is amended as follows:

“410.11 SCHEDULE XI – PARKING PROHIBITED DURING CERTAIN HOURS IN DESIGNATED PLACES.

Following are the streets, portions of streets and places in the City on which parking is prohibited during certain hours:

Street	Side Restricted	Hours From - To	Days of Week
(a) 4-Hours Parking:			
All City streets	Both	2:00 a.m. to 6:00 a.m.	All
(b) Library Parking: No parking drop-off area and additional handicapped spaces as set forth in Exhibit A, attached to Ordinance No. 11-25.			

(c) City Facility Parking Areas: There shall be no parking on or at any City facility as designated by the City Manager by the placement of signage at the facility from the hours of 3:00 a.m. to 6:00 a.m. on all days of the week. For purposes of this provision, the term “City facility” means any City-owned public parking area or City facility where parking is provided.

Section 2: Those provisions of Section 410.09, Schedule IX, of the Codified Ordinances of the City that were in effect prior to the effective date of this Ordinance and that are in conflict with Section 1 above are hereby repealed and shall no longer have any effect to the extent that they are inconsistent with the amendments adopted in Section 1 of this Ordinance.

Section 3: Section 410.10, Schedule X of the Traffic Code is amended as follows:

Section 4: Those provisions of Section 410.10, Schedule X, of the Codified Ordinances of the City that were in effect prior to the effective date of this Ordinance and that are in conflict with Section 3 above are hereby repealed and shall no longer have any effect to the extent that they are inconsistent with the amendments adopted in Section 3 of this Ordinance.

Section 5: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 6: This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the citizens of the City, and for the further reason that the safety of pedestrians and motorist will be improved; wherefore, this Ordinance shall be in full force and effect immediately upon its passage provided it receives the affirmative vote of five (5) members of Council, except that six (6) affirmative votes shall be required if all members are present at the meeting at which it is passed; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
