

**A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH SUMMIT COUNTY PUBLIC HEALTH FOR NPDES PERMITTED OUTFALL INSPECTION, MONITORING, AND SAMPLING SERVICES.**

WHEREAS, the City of Hudson is required under its National Pollutant Discharge Elimination System (“NPDES”) Municipal Separate Storm Sewer System (“MS4”) Permit to perform annual inspections of all designated stormwater outfalls in order to evaluate structural condition, evidence of illicit discharges, and overall water-quality indicators, all to ensure compliance with state and federal stormwater regulations; and

WHEREAS, to fulfill these requirements, the City contracts Summit County Public Health (“SCPH”) to perform the inspections, sampling and screenings and to provide documentation consistent with Ohio EPA standards; and

WHEREAS, SCPH has proposed a contract with a five-year term, from 2026 through 2030, ensuring continuity of service and regulatory compliance throughout the permit cycle; and

WHEREAS, the City administration is requesting City Council approval to enter a contract with SCPH for these NPDES Inspection Services in the total contract amount of \$119,494.51; and

WHEREAS, it is in the best interest of the City of Hudson and its residents to enter this governmental services contract under Hudson Charter Section 6.04(b)(3) and other law.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hudson, Summit County, Ohio, that:

Section 1. The City Manager is authorized to enter into a five-year agreement (2026–2030) with Summit County Public Health for National Pollutant Discharge Elimination System (“NPDES”) Municipal Separate Storm Sewer System (“MS4”) Permit outfall inspections and related services.

Section 2. That the aforesaid recitals are rendered to be the findings of this Council and are hereby incorporated into this Resolution.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4. This Resolution shall take effect and be in force from and after the earliest period allowed by law.
